

Copyright Information

Do you want to use an article or paper from NCPG publications?

Material that you find on the Internet is easily copied, but remember that it is covered by copyright laws. You need to get permission before you distribute any materials found here, with the exception of items used under fair use policies (see below).

Obtain permission before you

- reproduce copyrighted work in copies;
- prepare derivative works based upon the copyrighted work;
- distribute copies of the copyrighted work to the public;
- display the copyrighted work publicly

Requesting Reprint Permission

NCPG requires that you complete a Reprint Permission Request form (attached) to notify us that you would like to use material from The Journal of Gift Planning or the Proceedings of the National Conference on Planned Giving in the ways listed above. In most cases, there is no charge for reprinting information from these publications. However, if the information will be used in a for-profit context (e.g., to encourage clients to use a particular firm or service), there will be a charge. NCPG staff will notify you of the amount of this charge when necessary.

What is Fair Use?

You can use excerpts from copyrighted works without permission under the rules of "fair use." The 1961 Report of the Register of Copyrights on the General Revision of the U.S. Copyright Law cites examples of activities that courts have regarded as fair use: "quotation of excerpts in a review or criticism for purposes of illustration or comment; quotation of short passages in a scholarly or technical work, for illustration or clarification of the author's observations; use in a parody of some of the content of the work parodied; summary of an address or article, with brief quotations, in a news report..."
